	Safety Management	The company operates a health & safety policy and is annually audited (every year two different schools of the six) by an independent surveyor. The last audit was in April 2019 with a positive result, and recommendations made are being implemented.  During the year 2019, the company committed to fund some additional measures around the school including barriers and a speed bump, in areas where pupils and school buses cross each other. Total investment is c. £10k.
	Customer Engagement	The company has periodical operational performance review meetings as well as regular strategic liaison meetings with school senior management and representatives of the Department for Education. These meetings are attended at least once a year by directors.
	Communities	One particular thing that makes Lagan College different and unique is its membership of the Community of the Cross of Nails.





		On the 14th November 1940, much of the City of Coventry was reduced to rubble by German bombs. Two of the charred beams which had fallen in the shape of a cross were set on the altar and three of the medieval nails were bound into the shape of a cross.  The Cross of Nails is a very powerful and inspirational worldwide symbol of reconciliation and peace. There are now 160 of Cross of Nails Centres around the world, all working for peace and reconciliation within their own communities and countries. Lagan College is one of only four such centres in Northern Ireland and the only school. Lagan College takes great pride in its membership of this organization.
